Dear Ambassador Bellocchi:


I take great pleasure in informing you that my government has formally approved:

2. the new name of our Washington Office will be Taipei Economic and Cultural Representative Office in the United States. TECRO offices in other U.S. cities will be named "Taipei Economic and Cultural Office in (the name of city, such as New York).


I refer to your letter of December 20, acknowledging the change in the name of my office to the Taipei Economic and Cultural Representative Office in the United States (TECRO).
